On Approval of the Procedure for payment of a one-time benefit to victims of trafficking in human beings

Under Article 6 of the Law of Ukraine "On Combatting Trafficking in Human Beings", the Cabinet of Ministers of Ukraine hereby **decrees:**

- 1. To approve the Procedure for payment of a one-time benefit to victims of trafficking in human beings, as attached.
- 2. This Decree shall take effect on January 1, 2013.

PROCEDURE

for payment of a one-time benefit to victims of trafficking in human beings

- 1. This Procedure establishes the mechanism for payment of a one-time benefit (hereinafter the benefit) to victims of trafficking in human beings.
- 2. The benefit is due to a person whose status as a victim of trafficking in human beings has been declared in accordance with the law (hereinafter the person).

The payment of the benefit is carried out by the labor and social security institutions all at one time, in the amount of the subsistence wage for the respective category of persons (children under six years of age, children from six to 18 years of age, persons capable to work, disabled persons) established at the time of application by the person to receive the benefit.

3. In order to receive the benefit, the person, or the legal representative of the child-victim of trafficking in human beings who had been separated from his/her family, or of a disabled person, shall apply to the labor and social security institution at the place of residence (location) of the aforesaid person with the following documents:

Application in accordance with the form approved by the Ministry of Social Policy;

A copy of the certificate about the declaration of the person's status of a victim of trafficking in human beings;

A copy of an identification document;

A copy of a person's disability certificate (if necessary).

A foreigner or stateless person, who does not have command of the Ukrainian or Russian languages, shall complete the application with the help of an interpreter.

The labor and social security institution prepares the person's file, which shall be kept for three years following the payment of the benefit.

The benefit may be received by an authorized person, or a legal representative of the child-victim of trafficking in human beings who had been separated from his/her family, or of a disabled person.

4. The payment of the benefit shall be carried out based on a ledger, which is prepared by the labor and social security institution in accordance with the form, approved by the Ministry of Social Policy, via a state-owned postal service enterprise, or by transfer of funds to a personal bank account.

The expenditures related to payment for the services of the state-owned postal service enterprise caused by the payment of the benefit, shall be compensated from the state budget based on the application of the labor and social security institution.

5. The benefit shall be paid to the person no later than in one month after his/her application to the labor and social security institution, within the amount of funding provided for these purposes in the State Budget.
